CONSENT ORDER

The Parties to this action having consented to the following, it is hereby ORDERED that

- Defendant shall not request the Social Security Number ("SSN") of any applicant for a Georgia firearms license ("GFL") except to the extent that the FBI finger print card seeks any applicant's SSN. In the case of FBI fingerprint cards, Defendant may use such cards and leave to the agency capturing the fingerprints what information may be requested or required on such cards.
- 2. Within 30 days of entry of this Order, Plaintiffs shall provide Defendant with list of members а of GeorgiaCarry.Org, Inc. that have applied for a GFL from Defendant and that wish to have their SSNs purged from Defendant's records.

- 3. Within 30 days of receipt of the list described in No. 2 above, Defendant shall search her records and purge therefrom the SSNs of the people named on the list and she shall certify to Plaintiffs that she has done so. The SSN is satisfactorily purged by rendering the SSN illegible. Correspondence from defense counsel confirming the purging of the records will serve as sufficient certification.
- 4. Defendant shall not distribute the list, except as required by law, to anyone who does not need access to it in order to comply with this Order and Defendant shall ensure that the list and number of people on it is kept confidential.
- 5. Within 20 days of entry of this Order, Cherokee County shall pay \$4,862.50 to Plaintiffs' attorney for fees and taxable and non-taxable costs.
- 6. Within 10 days of the completion of the later of items 15 above, Plaintiffs shall notify the Court of the completion, whereupon this case shall be dismissed with prejudice.
