On motion of Commissioner Thaw, which carried unanimously, the following Ordinance amendment was adopted:

**AN AMENDMENT TO THE GLYNN COUNTY CODE OF
ORDINANCES, GLYNN COUNTY, GEORGIA, TO REVISE SECTION
2-11-7 PERTAINING TO EXPLOSIVES AND WEAPONS IN PARKS,
HISTORIC SITES, RECREATIONAL AREAS, AND THE ST. SIMONS
PIER.**

BE IT ORDAINED, by the Glynn County Board of Commissioners, this 5th day of June, 2008, that Section 2-11-7 of the Glynn County Code of Ordinances, Glynn County, Georgia, be and it is hereby amended to read as follows:

2-11-7 Explosives and Weapons.


- a. It shall be unlawful for any person to use or possess in any Park, Historic Site or Recreational Area any fireworks, explosives, firecrackers, sparklers, glow worms, noise makers, poppers, or snappers.
- b. It shall be unlawful for any person to discharge in any Park, Historic Site or Recreational Area, or St. Simons Island Pier any firearm, bow and arrow, spring gun, air rifle, slingshot, or any other device which discharges a projectile by any means.
- c. It shall be unlawful for any person to possess in any Park, Historic Site or Recreational Area, or St. Simons Island Pier a bow and arrow, slingshot, or any other device, other than a

"firearm" as defined by O.C.G.A. § 16-11-171, which discharges a projectile by any means.

This Amendment shall become effective upon passage.

EXPLANATION OF CHANGES

2-11-7 Explosives and Weapons.

- a. _____ It shall be unlawful for any person to use or possess in any Park, Historic Site or Recreational Area any fireworks, explosives, ~~or~~ firecrackers, ~~or~~ sparklers, glow worms, noise makers, poppers, ~~and~~ or snappers.
- b. _____ It shall be unlawful for any person to ~~use~~ discharge ~~or possess~~ in any Park, Historic Site or Recreational Area, or St. Simons Island Pier any firearms, bows and arrows, spring guns, air rifles, slingshots, or any other device which discharges a projectiles by any means. (~~Amended 06/27/05. O 2005-08~~)
- c. _____ It shall be unlawful for any person to possess in any Park, Historic Site or Recreational Area, or St. Simons Island Pier a bow and arrow, slingshot, or any other device, other than a "firearm" as defined by O.C.G.A. § 16-11-171, which discharges a projectile by any means.
