#### **VERIFIED COMPLAINT**

Plaintiff states the following as his Complaint:

- This is a Complaint for mandamus, and declaratory and injunctive relief, seeking to order
  Defendant to issue temporary renewal Georgia weapons carry licenses ("GWLs") to
  eligible Plaintiffs.
- 2. Plaintiff Iziah Smith is a natural person who resides in Richmond County, Georgia.
- 3. Plaintiff GeorgiaCarry.Org, Inc. ("GCO") is a non-profit Georgia corporation whose purpose is to foster the rights of its members to keep and bear arms.
- 4. Smith is a member of GCO.
- Defendant is the Judge of the Probate Court of Richmond County and has offices at 735
   James Brown Blvd., Suite 1000; Augusta, Richmond County, Georgia 30901.
- 6. On or about January 6, 2014, Smith applied to Defendant for a GWL pursuant to O.C.G.A. § 16-11-129.

- 7. At the time of his application, Smith also applied for a temporary renewal GWL ("TRGWL") and offered to pay \$1 for it.
- 8. Defendant refused to issue the TRGWL.
- 9. Defendant told Smith he has never issued a TRGWL and never intends to.
- 10. At the time of Smith's application, less than 90 days remained before expiration of Smith's then-current GWL.
- 11. Also at the time of Smith's application, Defendant did not know and was not made aware of any fact which would make Smith ineligible for a five-year renewal GWL.
- 12. On or about January 13, 2014, Smith was (apparently mistakenly) informed that Defendant would begin issuing TRGWLs.
- 13. Smith therefore returned to Defendant's office to request the TRGWL again.
- 14. Defendant told Smith that he would not issue Smith anything and told Smith to stop harassing Defendant's staff.
- 15. As a result of Defendant's failure to issue Smith a TRGWL, Smith's GWL expired before Smith's renewal GWL was issued.
- 16. Smith's GWL will expire in another five years and he will once again request a TRGWL at the time of his application for a renewal GWL.
- 17. GCO has other members who live in Richmond County and who request and desire TRGWLs when they apply for renewal of their GWLs.

### **Count 1 – Violations of O.C.G.A. § 16-11-129(i)(2)**

18. By failing to issue Smith and other renewal GWL applicants TRGWLs upon request, Defendant violated O.C.G.A. § 16-11-129(i)(2).

## Count 2 - Violation of Georgia Constitution Art. I, Sec. I, Par. VIII

- 19. By denying Smith a TRGWL, Defendant made it prohibitive for Smith and other renewal GWL applicants to carry a pistol outside their homes, automobiles, or places of business.
- 20. The handgun or pistol is the quintessential firearm for self defense in the United States.
- 21. By denying Smith and other renewal GWL applicants a TRGWL, Defendant has violated Plaintiffs' constitutional rights under Georgia Constitution Art. I, Sec. I, Par. VIII.

## <u>Count 3 – Violation of Second Amendment to Constitution of the United States</u>

22. By denying Smith and other renewal GWL applicants a TRGWL, Defendant has violated Plaintiffs' constitutional rights under the Second Amendment to the Constitution of the United States.

### **Relief Demanded**

Plaintiff demands the following relief:

- 23. A writ of mandamus compelling Defendant to issue a TRGWL to eligible renewal GWL applicants.
- 24. A declaration that Defendant is required to issue TRGWL to eligible renewal GWL applicants upon request and payment of \$1.
- 25. The costs of bringing and maintaining this action, including reasonable attorney's fees, pursuant to O.C.G.A. § 16-11-129(j) and 42 U.S.C. § 1988.
- 26. A jury to try this case.
- 27. Any other relief the court deems proper.
